

Role of the Working Groups



Role of the Working Groups

- *Oral and written feedback* on draft materials that will be used in the development of the CLWUP.
- Advice and guidance regarding upcoming public engagement activities. For example, what are the best materials to present? What are the best questions to ask?
- Help *promote public activities and events* through local networks to increase public participation and input.
- *Provide access to materials* that may assist with the plan development (e.g., photos).
- Guidance on key issues that are important on a particular island.
- Knowledge and experience on the topics covered in the plan.

Expected Schedule & Time Commitment



- Working Groups are expected to meet virtually (via Zoom or other such platform) several times during the course of the project.
- There will be one kick-off meeting (today!)
- Then one meeting leading up to each major round of public engagement or release of major plan materials.
- This will likely amount to at least six meetings held approximately once every other month.
- Members will often be given "homework" between meetings to help support development of the CLWUP.

Fourth Working Group meeting – Focus on reviewing policy framework and online public survey before they are released

Fifth Working Group meeting – Focus on reviewing draft goals, policies, and strategies, and content and format for in-person public engagement

Sixth Working Group meeting – Focus on reviewing draft CLWUP, and content and format for in-person public engagement

Recap: What We Heard from the Town Hall Meetings



What is Important to Protect? Culture & Heritage

- Historic structures, buildings, places
- Native-owned (legacy) historic lands and homes
- Protecting names of estates and communities.

Coastal and Upland Natural Resources

- Coastal and nearshore resources, such as bays, salt ponds, mangroves, and coral reefs
- Natural resources of cultural significance, specifically Maroon Ridge and others.
- Protection of aquifers, guts, trees and forests/rainforests

Economic Opportunities

- Preserve agricultural lands and promote agricultural uses

What Needs to be Strengthened? Culture & Heritage

- Resources for dilapidated structures
- Build pride and interest in cultural resources and USVI heritage
- Promote USVI's history and culture through tourism in a sustainable and respectful way

Development, Redevelopment & Conservation

- Revisiting and revising rules and regulations
- Incentives for better development outcomes
- Better enforcement of rules and regulations





What Needs to be Strengthened? cont. Mobility & Connectivity

- Connect residential neighborhoods with schools and shopping areas via bike and walkways
- Improve roadway design
- Invest in VITRAN

Protecting Coastal and Upland Natural Resources

- Restore the island's coastal and upland natural resources
- Strengthen protection to improve health and quality

What should be Transformed? Development, Redevelopment & Conservation

- Transformation of the refinery
- Focus on redevelopment verses new construction

Economic Opportunities

- Increase support and opportunities for agriculture

Mobility & Connectivity

- Build adequate sidewalks, bike lanes, and walking paths that connect neighborhoods
- Expand transit service, efficiency, and reliability





What should be Transformed? cont. Government Responsibility & Capacity

- Need for more government capacity to provide existing services
- Be cautious about adding new responsibilities to government
- Better government transparency

Quality of Life

Transform services such as . . .

- Education
- Parks & Recreation
- Resources for Seniors

Draft Formative Issues

The CLWUP process has reached an important stage where the insights from research, interviews, and public engagement can be organized into a series of draft formative issues . . .

Governing Effectively

Decisions related to land and water use should be based on sound planning and enforced by agencies with adequate resources.

Celebrating Our History and Culture

Restoring, preserving, and cultivating awareness of cultural resources in land and water use policy is critical to the economic success of the USVI and cultural experience of future generations.

Providing Homes for Everyone

A diverse and abundant supply of safe and healthy homes is fundamental to economic, social, and environmental prosperity of the USVI.





Connecting People, Commerce, and Places

The transportation system in the USVI should connect land and water uses in a way that is safe, efficient, and provides choices for different ways to get around.

Protecting Natural Resources

Land and water use policies must reflect that USVI's natural resources are central to local cultural identity, public health, ecological systems, and economic well-being.

Improving and Maintaining Quality of Life

Land and water use policies should establish sustainable funding sources, foster opportunities for collaboration, and build a system of amenities that fosters civic responsibility and community pride.

Addressing Climate Change

The USVI must adopt land and water use policies that anticipate the impacts of our changing climate and strengthen our ability to meet these challenges.

Economic Opportunity & Resilience

Land and water use policies will look to diversify the USVI economy and build on the strengths and opportunities specific to its different islands.

Sustainability and Stewardship

The approach to building infrastructure and providing everyday services to residents and business should be done in a manner that is environmentally sustainable and healthy for future generations.

Development, Redevelopment, and Conservation

The CLWUP will provide a clear framework for where development should occur and where it should not occur.
